# Introduction to the Service

Our Crossroads Together team, based at four Extra Care Schemes in Stockport, offer the residents practical and emotional care and support within their own homes. Whilst the Extra Care setting provides the residents and their families with a greater sense security, our aim is to help individuals maintain their independence.

Our professional carer support workers, work with the residents and their families to create a person centred care plan which could involve personal care (bathing, dressing, toileting), support with medication, light domestic duties and facilitating residents to enjoy activities at home and out in the community.

We also provide tenants with a range of organised group activities in the communal areas of the sites. These can include games, arts and crafts, exercise classes, 1:1 activities. The activities we provide enrich the lives of the tenants and support their wellbeing.

Activities Coordinator's will be encouraged and supported to see their work in terms of helping people to achieve their goals and desired outcomes and not just to perform the prescribed tasks. The job description is a broad description of the duties of an activities co-ordinator will be expected to perform with some examples given for what the main duties actually involve. The exact duties to be carried out for each person with care needs are not limited to those examples, these will be agreed with a senior member of staff before the activities co-ordinator begins providing support and will then be set out in a care plan/support plan.

Comprehensive induction training will be provided. Staff will not work unsupervised until induction has been successfully completed, activities coordinators will be offered the opportunity to achieve their Care Certificate

Crossroads Together provides support to residents 24 hours a day, 365 days a year. The activities co-ordinator working pattern will be agreed between them and a senior member of staff.

### Main aims of the post

- To provide support to carers and people with care needs including emotional support.
- To engage tenants of Stockport Extra Care sites with meaningful activities
- To seek feedback from tenants to drive the quality of the service

# Duties to include

- 1. To provide emotional support, companionship and a safe environment for those in need of supervision and help. This can be provided through social interaction, shopping trips, local outings in the community, cleaning together, having a drink and chat, etc.
- 2. To plan and provide support with organised group activities for people with care needs.
- 3. To engage with tenants and provide activities that are meaningful.
- 4. To support the service to compile feedback from tenants through tenant meetings, family meetings, survey/paper feedback
- 5. To support the person with care needs with activities outside their home with support from members of the care team.

# Health and safety

- 6. To report any concerns about tenants wellbeing and welfare to a line manager
- 7. To implement, operate and maintain safe systems of work in accordance with Crossroads Together policies, procedures and guidance, training and associated risk assessments.
- 8. To report to your manager any situations or issues for concern relating to significant foreseeable risks, incidents (including near misses) and / or accidents which give cause for concern in relation to safe systems of work (affecting your own health and safety or that of others affected by your work activities).

### General

- To be committed to safeguarding and promoting the welfare of vulnerable adults and children.
- To work at all times within the philosophy and policies of Crossroads Together .
- To comply with the Health & Safety at Work Act 1974 and with Crossroads Together policy, paying particular attention to the reporting of dangerous situations.
- To respect the personal choice and lifestyles of colleagues, carers, and people with care needs, ensuring that Equal Opportunity principles are applied at all times.
- To comply with the Code of Conduct.
- To undertake any other duties that may be considered commensurate with the level of the post and that are set out in the care plan.
